In July 2016 CMS is proposing to implement a system for all Medicare- and Medicaid-participating nursing homes to electronically submit staffing information to CMS as required by section 6106 of the Affordable Care Act, and funded by the IMPACT Act of 2014. The collection of this information will allow CMS to report on staffing levels throughout the year, collect data that is auditable, and report on new measures such as turnover and tenure. CMS will be soliciting facilities to submit data on a voluntary basis beginning in October of 2015. Registration for voluntary submission will allow facilities to work through their processes to submit the data, in advance of the mandatory submission period, which is proposed to begin in July 2016.
